TEREA MOBILIZES ITS EXPERTISE FOR THE DEVELOPMENT OF LOW-CARBON PROJECTS AND POLICIES

Development of forest carbon projects: Improved Forest Management (IFM), Reducing Emissions from Deforestation and Forest Degradation (REDD+) including conservation, sustainable forest management, and increased forest carbon stocks, Afforestation, Reforestation, and Revegetation (ARR), eligible for voluntary and regulatory markets:

- Feasibility studies
- Development of project documents (PIN, PDD, etc.)
- Development and application of methodologies for certification (emission reductions accounting, MRV - Measurement, Reporting, Verification, etc.)
- Identification of technical and financial partnerships
- Support for the labeling of verified carbon units (carbon credits) and credit commercialization
- Project monitoring and evaluation

Implementation of awareness and promotion actions for the project:

- Support for the development of national emission reduction policies and the maintenance and increase of carbon stocks:
 - Development of Nationally Determined Contributions (NDCs)
 - Development and implementation of national REDD+ strategies
 - Integration of climate and carbon issues in forest policies (forest code, forest-climate strategies, etc.)
- Development and application of carbon accounting tools and methodologies
- Carbon Footprint assessment
- Training on climate issues and best practices
